TOGETHER WITH ANY COURT COSTS, ATTORNEY'S FEES AND COSTS OF COLLECTION THE SELLER MAY INCUR IN ENFORCING THE TERMS OF THIS AGREEMENT. IF LEGAL ACTION BECOMES NECESSARY BY EITHER SELLER OR BUYER, IT IS ALSO AGREED THAT THIS OR ANY CONTEMPORANEOUS OF SUBSEQUENT AGREEMENT WILL BE GOVERNED AS TO VALIDITY, INTERPRETATION, CONSTRUCTION, EFFECT AND IN ALL OTHER RESPECTS BY THE LAWS OF THE STATE OF INDIANA.
THE BUYER FURTHER GRANTS TO THE SELLER A SECURITY INTEREST IN BUYER'S EQUIPMENT, CONTRACT RIGHTS, INVENTORIES, RECEIVABLES AND PROCEEDS OF SALES COLLATERAL TO SECURE THE BUYER'S PERFORMANCE OF ALL OBLIGATIONS.
